Re: Director's Summary of Current Events

Listed below are activities the department has been involved with during **September and October 2020**.

NEW! Eco-BLITZ:

Park visitors can now assist the department by participating in a simple natural resource program by joining the Maricopa County Parks and Recreation Department for the first-ever Eco-BLITZ (November 2020 through November 2021). Using the free web-based I-Naturalist application, park visitors can visit their favorite Maricopa County regional park, locate a plant or animal, take a few pictures, attempt to identify the species so you are learning as you go, and upload the photos to the I-Naturalist app. Observations will be automatically recorded under the Maricopa County Parks and Recreation Department's Eco-BLITZ program. Estrella - Tres Rios Golf Course:

In response to the Request for Proposal to manage the Tres Rios Golf Course, the evaluation committed selected Southwest Golf Management, LLC (SWGM). SWGM's principles have over 30 years of public and private golf course management expertise. They previously managed three golf courses in Arizona, one of which was just recently sold (Falcon Dunes) and they currently manage three golf courses in California.

On September 16, the Board of Supervisors approved the termination of Tres Rios Golf, LLC (C-Bons) and concurrently approved the assignment to Southwest Golf Management along with an amendment to the existing Use Management Agreement. The purpose of the amendment was to address, among other things, the following:

- Concessionaire shall provide documentation to demonstrate adequate financing to complete phased improvement projects per Amendment Five Exhibit A;
- 2. Concessionaire shall establish a reserve fund that shall forfeit to Maricopa County upon termination for cause or default;
- 3. Amend the payment schedule;
- 4. Modify the term of the agreement through December 31, 2050;
- 5. Other administrative actions.

Adobe Dam:

Arizona Model Pilots Association's Management Agreement comes to term on January 6, 2021. They have been a concessionaire at Adobe since 1985, having had two previous management agreements. A Letter of Expression of Interest (LOI) for the management, operations, and maintenance of this model airpark complex or alternate recreation facility was issued on October 15 with a response date of December 3. Due to the proximity of the airpark location within this flood impoundment area along with terrain and land-use restrictions, we are not anticipating a large response to this solicitation.

100 Miles in 100 Days Challenge:

It's time to lace up your shoes and dust off those bikes and saddles for the 100 Miles in 100 Days Challenge! The program officially began on November 1, 2020, and runs through February 8, 2021. While several slight modifications have been made this season for participant and staff safety, efforts have been made to ensure the program remains close to its original premise. This season, participants can look forward to a variety of scavenger hunts sprinkled throughout the park system which are designed to encourage them to explore new trails. Plans are in the works for a couple of other activities to keep participants engaged, but you'll have to

join the Challenge to learn more. Currently, there are roughly 1,100 participants registered with new Challenge members signing up daily. Program details can be found at marricopacountyparks.net.

Coalition for Recreational Trails (CRT's) Award:

The Maricopa Trail and Park Foundation's (MT+PF) *Maricopa Trail Volunteer Stewardship Program* was selected to receive one of the CRT's national awards in 2020 in the category of Engaging Public Sector Partners. The MT+PF received an Arizona State Parks and Trails Recreational Trails Program (RPT) grant earlier this year. The grant funds are used to support segment stewards and trail work volunteers with trail maintenance, etiquette, and safety training on segments of the Maricopa Trail and connecting trails and trailheads within the Parks' system.

Administration

Contract Administration:

Six Flags Hurricane Harbor: The original agreement provided for the development of two parcels in three
phases. Parcel 1 (Phase I, II) was the main waterpark and Parcel 2 (Phase III) contained approximately twelve
acres not connected to the waterpark, as it was separated by a four-acre parcel and a County Park road. Parcel
2 (Phase III) remains undeveloped.

In 2018, Parks issued a Notification of Failure to Develop which provided an option to offer a 3.5+/- acre parcel in exchange for returning the 16+/- acre parcel for future development by the department. Earlier this year, Parks re-approached Six Flags and they consented to the exchange via an amendment to the agreement. Phase I and II have been completed to the County's satisfaction. Phase III (Parcel 2) proposed development is directly across from the main entrance to the waterpark. Although it is still separated by a County Park road, its proximity to the entry of the waterpark is a better alternative for the concessionaire for their employee parking and to allow additional guest parking. For the last three years, the concessionaire has been issued a Special Use Permit to use Parcel 2 for their employee parking.

This transfer of land benefits the concessionaire as well as the County as the parcel can now be solicited for other concession recreational opportunities.





Planning and Development Division

Project Management

- The Department Project Manager (PM) has completed the Estrella host site waterline rehabilitation project near
 the old rodeo arena area. New isolation valves were installed, the corroded galvanized pipe was replaced with
 sustainable PVC piping, and new electrical pedestals were installed at the sites.
- The Group Campground host site project is moving along at Lake Pleasant. The host site covers have been ordered, the electrical permit has been received, and the septic system and potable water connections have been designed. This project will be completed by the end of the year.
- The PM has received quotes for major park projects including several septic systems and campground electrical renovations at Lake Pleasant. Subsequent inspections of the ET beds have indicated substantial repairs are required to the Desert Outdoor Center, RV Dump Station, and Group Campground beds. Due to the regulatory nature of the ADEQ permitted septic system beds, the beds are now the department's priority and a request to utilize the campground electrical renovation funding has been submitted to the Board of Supervisors for approval. Due to the cost of these improvements, many of these projects will be bid through the County's Procurement office.

Trades Crew

- Department Electricians completed the installation of retrofit LED lighting on the host sites at San Tan Mountain Regional Park. The electricians are systematically making their way through the parks to upgrade and complete the LED lighting improvements that will improve electrical efficiency and reduce long-term maintenance.
- The Trades Crew completed a boulder barrier system at Estrella Mountain Regional Park which prevents vehicles from driving around the closed gates at the entrance to the park to gain unauthorized access.
- The Trades Crew has removed the three electric pedestals, hose bib risers, sewer cleanouts, BBQ grills, and the septic tank access riser at Estrella Mountain Regional Park along the golf course access road. This maintenance project is in preparation for the grand reopening of the Tres Rio Golf Course this month.

Trails Crew

The Trails Crew is completing the installation of new trail signs and maintenance work on the trails in preparation
for the busy hiking season. The trails section is also assisting with a new trailhead kiosk installation at the
Maricopa Trail Sun Valley Trailhead.

Maricopa Trail, Sun Circle, and Trail Facilities:

- Agreement preparation/negotiations:
 - City of Phoenix IGA for Segment 1 Sun Circle Trail was sent back to Phoenix Street Department for review on 10/26/20; Segment 7 is in review by Maricopa County Attorney's Office and Real Estate Department.
 - o ADOT Preparing permit for SR85 crossing Segment 33; waiting on contractor insurance information.
 - AZGFD Segment 14 license renewal was approved by their Commission on 8/19/20; the draft license is in review by Maricopa County Attorney's Office and Real Estate Department.
 - WAPA (Western Area Power Administration) License applications (four) for Segment 76 submitted 10/28/20.
 - o CAP (Central AZ Project) License application for Segment 76 in process.
 - o Avondale Segment 1 route determination coordination is in process.
 - o MCFCD (Flood Control District) Permits submitted for Segment 27 and 35.
- Maintenance
 - Segment 22 Sears Fire burned north eight miles of Trail; dragged brush, removed trees, unclogged culvert, and inspected damage 10/19/20.
- Trailheads
 - Segment 27 Bush Highway Bureau of Reclamation approved Categorical Exclusion 7/30/20.
 Construction is scheduled for December 2020 by MCDOT.
 - Segment 11 Preparing display for a new kiosk at Sun Valley Trailhead.
- Route Determination Developed alternate routes for Segment 77 Vulture Mountain to Lake Pleasant and Segment 76 White Tank to Vulture Mountain. Parks' management selected primary routes in August 2020. Currently meeting with landowners (Bureau of Land Management, Central AZ Project, Bureaus of Reclamation, and Western Area Power Administration.

Natural Resources

Fuel Fire Reduction Grant: The Department received a grant for fire fuel reduction from the Maricopa County
Department of Emergency Management (MCDEM). The grant was used to hire a contractor to remove dead
vegetation from the trail edges (6-10 ft) along a 2.5-mile section of the Metate and Spur Cross trails and the
parking lot. The contractors raked, weed whipped, bagged, and removed six trailers full of dead and dry invasive
vegetation.

The Department also received a larger \$87,000 grant for an Invasive Species Management Program for the Spur Cross Ranch Conservation Area Restoration Project from the Arizona Department of Forestry and Fire Management (DFFM). This grant will include 2-years of invasive species treatment in approximately 75-100 acres of the park. The treatment area includes invasive hot spots that occur within the 30-100 ft buffer of the trail edges and riparian areas. The areas were selected to strategically manage invasive species, reduce fire fuel load, and to prevent further spread of invasive species. The project also includes the development of native plant propagation beds which will provide staff with native seed. The seed can be used for planting in areas of invasive species removal, burn areas from recent fires, future restoration projects, and a potential seed collaboration with our partners. The species propagated include the less common species, especially pollinators.

The Department Natural Resource Specialist continues to work with plant experts from the Midwest and local
partners on creating a local Floristic Quality Assessment for Maricopa County. This process utilizes national
and regional botanists and plant experts and takes several days to review and assign quality ratings to hundreds
of plant species.

Buckeye Hills Regional Park

• Joe Foss shooting range has good public recreational shooting success with regular monthly increases in public visitation and use.

Cave Creek Regional Park

- The Nature Center display layout has been reconfigured to allow for social distancing. Supply and merchandise orders continue to be submitted for the upcoming season.
- Maintenance staff, volunteers, and the interpretive ranger completed the following maintenance projects:
 - Cleared and hauled out about 20 truckloads of brush to reduce wildfire fuel loads around the park facilities and parking lot.
 - o Trees around the Nature Center, campground, and roadways have been thinned/pruned/fertilized.
 - The mine closure project is underway, pictures of the individual mines are being taken, an assessment of the mines will be completed and prioritized to determine if some of the work will have to go out for bid.
 - o The Nature Center floors have been deep cleaned and buffed-They look amazing!!!!!
 - o All facilities are being deep cleaned for the upcoming season.
- The staff has been training new Park Host for the season. We have also been working on the POS data for the new system.
- All septic tanks have been pumped for the season.
- Staff collected and planted prickly pear cuttings in the desert gardens at the Amphitheater.
- Trimmed trees, cactus, and shrubs along some of the trails and completed trail maintenance to the Nature Center connector path to the Overton Tail.
- Completed some site visits to mines to determine what repairs are needed.
- Wild at Heart, an Arizona-based raptor rescue organization, released six American Kestrels (falcons) at the Nature Center.
- Cave Creek Trail Ride concessionaire has arrived for the season and will start trail rides on October 31.

Estrella Mountain Regional Park

- The Park Interpretive Ranger continued online programming engagement through Facebook.
- Staff set up game cameras in a wash along the Coldwater trail. Several bobcats have frequently been visiting and providing valuable information about wildlife movement in the park.
- In-person programming started back in October with mixed results for the registration process. Our first bird walk was very successful, with all ten spots filling quickly and everyone attending the program. The other two programs (a sit-down presentation at the ramadas and a guided hike) both had full registrations, however, only a few (1-4) showed up for the program. Staff will continue to advertise and determine what format and programs best suit the visitors' needs and the park's operation mode.
- Estrella Park staff and hosts continue to clean ramadas and picnic areas for customers enjoying a day in the park. Some family gatherings and a wedding party enjoyed the facilities. Reopening and reorganizing the nature center went smoothly with all areas sanitized and the public properly spaced apart.
- Hiking continues to increase with the cooler weather. Several smaller hiking groups are beginning to appear.

Hassayampa River Preserve

- Park staff prepared the Visitor Center's reopening in October.
- The Preserve was recognized at a virtual awards ceremony by the Arizona English Teachers Association with a Community Literacy Award for hosting a Nature Poetry Contest in April.
- The Preserve participated in National Cleanup Day by hosting an Adopt-a-Highway cleanup for our one mile stretch of Hwy 60 bordering the Preserve. Three volunteers from the public, four regular park volunteers, and park staff picked up a total of twenty-nine bags of trash! Boy Scout Troop 299 also continued repairing the Martin gravesite fencing for National Public Lands Day on September 26.
- The Preserve was a virtual partner with the Town of Wickenburg in promoting Bats and Buzzards on the Bridge, a wildlife viewing event in Wickenburg. The community was provided with online resources and information highlighting the migrating turkey vultures and seasonal resident Mexican free-tailed bats that can be seen this time of year from the pedestrian bridge crossing the river in Wickenburg. Previous years' events were in-person, but due to COVID, this year everyone was encouraged to go to the Bridge on their own over several weeks when the vultures and bats were most active.
- The Preserve switched to winter hours and resumed being open on Wednesdays. The Visitor Center opened to the public after being closed since April.
- The interpretive ranger resumed programming this month and most programs filled up to a maximum capacity of ten people.
- Returning and new hosts arrived for the season this month. Several new and returning community volunteers roved the trails and worked on special projects.
- Ranger Amber from the Desert Outdoor Center started a mural painting project in the Visitor Center.

Lake Pleasant Regional Park

- Installed eight decorative rock boulder benches around the playground at the Discovery Center.
- Garage doors and an air compressor were installed at the Government Dock and Navigational Aide Boathouse.
- As of September 29, all the septic tanks at Lake Pleasant were pumped as part of the CARES funding due to the spike of attendance due to COVID-19.
- On September 8, the Lake Pleasant Supervisors met with the Central Arizona Water Conservation
 District/Central Arizona Project and other related agencies to the Lake for a functional exercise discussion on
 potential emergency water level release scenarios. Further follow-up discussions are scheduled in the coming
 month.
- On September 20, the park hosted the *16th Annual Dam Good Run* in association with Aravaipa Running to the delight of 198 socially distanced participants with staggered start times throughout the day.
- On September 26, the Lake hosted the National Public Lands Day volunteer cleanup event with 26 volunteers picking up approximately 75 large bags of trash from the shoreline.
- Discovery Center is scheduled to open Fridays and Saturdays, beginning November 6.
- A proposal for bringing back shoreline camping has been submitted for review. The new shoreline camping will be a little different from years past. The campsites will be designated to help ensure less litter, resource damage, and clearly define designated areas for camping access.
- Park hours changed to Winter hours on October 19 to reflect 6 a.m. to 8 p.m. daily at the Main Entrance and 6 a.m. to 4 p.m. Friday-Sunday at the North Entrance.
- Completed road re-grading repairs in the areas of Two Cow Cove, Desert Tortoise Road Spillway, and Sunfish Lane.
- Successful relaunch of interpretive programs during COVID with four programs offered and approximately fifteen attendees at each program (60 participants in total for month).
- Twenty-five Boy Scouts cleaned up the entire Desert Tortoise and Two Cow Road as part of an eagle project.
- Thirty-eight volunteers from Luke Air Force Base came out to help remove and smooth out the rocky Roadrunner Trail.
- Central Arizona Project, Bureau of Reclamation, and other partner agencies successfully performed a functional exercise for the New Waddell Dam and 11 dikes to prepare for a catastrophic event.
- Castle Creek Triathlon occurred on October 3, with approximately 150 participants, scheduled at staggered start times to limit capacity at any given time to ten participants socially distanced at all times in any given area.
- Crown King Scramble (running marathon) was canceled due to wildfires in the area near the park.

McDowell Mountain Regional Park

- Purchased supplies and constructed the COVID plexiglass screens that are to be installed in the nature center at each park in preparation for our reopening in October.
- There was a major waterline break in the park on September 25. The Trades Crew was able to repair the line, however, the total loss of pressure in the waterline and the equipment's age led to compounded issues with the water pumps. With the Trade's Crew help, we were able to get the pumps back online and water flowing in the park.
- The first SUP event of the season was held with approximately 415 participants. *Javelina Jundred* was successfully executed within COVID guidelines and had no incidents or complaints.
- Nature Center was reopened on October 5. The Group area and ramadas are open for reservation of 50 people
 or less.
- Hosts have returned to the park for the season, just in time for our unusually busy campground for October. We held a Welcome Host Powwow on 10/20 to welcome back our returning hosts and introduce the new hosts joining us this year.
- The post-fire assessment was completed on October 8 by the Parks Natural Resource Planner, Interpretive Rangers, and the Park Supervisor to evaluate the damage to park flora during the McDowell Fire in August 2020. This data will help make future conservation decisions regarding fire restoration.
- Continued work in Mink's camp: installing shades, clearing areas, and preparing the portable restroom left by a Concessionaire to convert from electrical to solar panels.
- Two large special events were approved by the County's Planning & Development Department and the Parks
 Department. Events were reformatted into a wave start to spread out participants' arrivals and race times, which
 allowed the weekend events to run very smoothly and lessened event congestion in the park.

San Tan Mountain Regional Park

- Staff used the tractor to transplant a Palo Verde from near the entry window into the new tortoise habitat. This eliminates a future road obstruction while helping create needed shade for the tortoise burrows.
- San Tan participated in a history scavenger hunt put on by the Town of Queen Creek for their virtual Founders
 Day celebration. Eight families stopped by the park to read a poster about Mansel Carter to solve a puzzle and
 get a prize from the Town.
- San Tan had 12 programs with a total of 100 participants. This includes partner programs led by our volunteer biking group and the Master Gardeners.
- The ranger held a 100 Miles Challenge info session at the trailhead and spoke with approximately 30 people.
- Park Staff and the San Tan Valley Master Gardeners continue to improve the Interpretive Trail and recently planted 10 prickly pear cacti and cholla varieties to illustrate the difference between plants.
- The Trades Crew installed light fixtures in the two new park host site Ramada's and around the Visitor Center complex for security. They also upgraded to LED lights in existing poles in the parking lot.

Spur Cross Ranch Conservation Area

- · Merchandise and supply orders are being created for the upcoming season.
- The Interpretive Ranger and his weekly volunteers completed the following maintenance projects:
 - o Trees and shrubs along Metate and Towhee Trails were pruned.
 - Trees and shrubs were pruned and grasses trimmed on the lower stretch of Dragonfly Trail in anticipation of reopening of connecting Jewel of the Creek Preserve on 9/16.
 - Cabling, posts, and an "Area Closed" sign installed across Boca Grande Wash to prevent off-trail hiking from the Dragonfly Trail.
 - The area around Solar Oasis was cleared of dry grasses for fire prevention. Lily pads and rushes were also removed from the pond perimeter.
 - Barricades and "No Parking" signs were replaced along the entry road in anticipation of the busy season.
- The entry station opened on October 10 and is being manned seven days a week.
- The trails volunteer pruned shrubs & trees along Dragonfly Trail & Jewel of the Creek. They also completed line trimming of dry grasses along Dragonfly Trail and removed protruding rocks on Dragonfly Trail.
- On October 9–16, HMI Landscape Company completed a grant-funded Fuel Reduction Project on the Metate/Spur Cross Loop.

Usery Mountain Regional Park

- Two new Park Hosts arrived in late September. They will be assisting in the campground and helping at the Entry Station.
- The Park Supervisor offered a virtual "Lunch and Learn" series for Usery staff throughout September; lunch provided on-site with an Arizona Parks and Recreation virtual conference session provided on our big screen. Staff occupied their own table, each spaced six feet apart.
- Maintenance staff completed general maintenance (weeds, trimming) to all 75 of our campsites, including digging and installing all-new fire pits/grills to each.
- Maintenance staff completed 15 campsites that still required decomposed granite added to the picnic areas.
- Usery Park had six new Park Host couples and one individual Host return in October. The positions will work at the Entry Station, Nature Center, Archery Range, and Campground. Their assistance is much needed as Usery attendance has begun to increase greatly.
- Ranger Brennan offered one virtual outreach program to a senior living center in Scottsdale; clients could remain in their rooms and participate via phone conference; 20 participants enjoyed his *Crazy Ranger Stories* program.
- Ranger Brennan offered two park ranger programs in October. To be more creative in seeing visitors, he brought a table and materials to the trail and allowed participants to join him at any point during the 1.5-hour timeframe.
- All 17 septic tanks were pumped at Usery Park total.
- Maintenance staff completed all repairs to our Viewing Pond; Arizona Game and Fish were a tremendous help troubleshooting issues. Mesa Community College shared some of their aquatic plants from their popular Cienega Pond for us to add some plant life and assist with aesthetics. Arizona Game and Fish hopes to have it stocked again with topminnow fish by December.
- A small fire started at the Usery Park Playground on October 15. Fortunately, it was spotted early, and the staff
 was quick to react. Two members of the public also jumped in to assist with buckets of water. The fire smoldered
 for a couple of days due to very dry mulch, but the staff continued to keep a close eye and water on it. On
 October 29, Maintenance staff removed all of the burnt mulch and replaced it with extra piles already on hand.
- REI/AZ Outdoor Adventures hosted a small mountain bike ride with eight people in attendance.

White Tank Mountain Regional Park

- Staff prepped the Nature Center for reopening on October 5 by deep cleaning, organizing, and installing signage to encourage COVID-19 public safety procedures.
- After many park host staffing changes throughout the summer, the last park host position was filled this month, just in time to reopen the Willow Campground from its summer closure.
- Maintenance staff installed new keypad locks on the Willow Campground shower doors to ensure that registered campers have exclusive use of these showers.
- Maintenance Worker Ryan traveled to Lake Pleasant to assist with Navigational Aid work and Estrella Park to focus on trimming the many young trees.
- White Tank received a new tractor and staff participated in a tractor training class at the end of the month. With
 the addition of this equipment, maintenance staff used the new park tractor to clear out old flash-flooding wash
 debris, strategically place boulders in needed areas around the park, and cleared out old piles of dirt from
 parking areas that could not be done by hand.
- Six new host couples joined the White Tank team this 2020/2021 fall-spring season.
- The White Tank Sonoran Desert Tortoise was moved inside the Nature Center for the winter to prevent him from hibernating. Cera is slightly underweight, so staying inside this winter will keep him awake so that he continues to eat and maintain a healthy weight. Ranger Justin worked with a park volunteer, Mike, to design and build a new tortoise habitat that will keep Cera happy and allow park visitors to learn about him while on exhibit in the Nature Center.
- Interpretive Ranger programming started back up in October with pre-registration and a maximum of ten participants per program. The Audubon Society morning *Bird Walk* with Joe Ford was the most popular walk with six park patrons attending.
- Deep cleaned the bathrooms that had been closed for the summer.
