PARKS AND RECREATION COMMISSION MEETING

ITEM #2 - Proposed Fee Schedule - Aimee Upton, Administrator - Maricopa County Parks and Recreation Department - INFORMATION/DISCUSSION ITEM

- Ms. Upton presented to the commission the history of park fees, funding sources, the reason for fee increases and the proposed fee increases. The last major fee revisions were approved in December 2009. If the fees are approved by the Board of Supervisors, implementation would begin in April 2014. Operating funds are derived from User fees (69%), Concessions (18%), and General Fund (13%). General funds have steadily decreased since FY10 while central service costs increase. Operating costs continue to increase faster than revenues are received. Aging vehicles along with increased system repairs, central service costs and Risk Management charges contribute to Parks budget deficit. Fee changes are proposed for some park vehicle entry fees, annual passes, camping fees, facility rentals, Desert Outdoor Center fees and other miscellaneous fees. The proposed increases were based on a cost of service study and benchmarking data pulled from surrounding entities offering similar services.
- Commissioner Stapley commented that a periodic review of fees is needed. Many of the fees have not changed in almost 5 years and are not proposed to be changed at this time; additionally, most of the proposed changes are small. Chair Yoshioka commented that Parks is offering cost effective charges to the public while offering enough resources.
