Re: Director's Summary of Current Events

Listed below are activities the department has been involved with during March and April 2022.

Federal Legislative Items:

U.S. Senators Shelley Moore Capito (R-W.Va.), Martin Heinrich (D-N.M.), Roy Blunt (R-Mo.), and Tom Carper (D-Del.) are sponsoring the bipartisan Recovering America's Wildlife Act across. On April 7, 2022, the landmark conservation legislation was voted out of the U.S. Senate Committee on Environment and Public Works (EPW) with bipartisan support. The legislation now heads to the Senate Floor for consideration. The House legislation advanced out of the House Natural Resources Committee in January.

The legislation invests in proactive, on-the-ground conservation work led by states, territories, and Tribal nations to support the long-term health of fish and wildlife and their habitat all across America. These locally-driven, science-based strategies would restore populations of species with the greatest conservation need. Since its introduction in July 2021, the Recovering America's Wildlife Act has gained significant momentum with 32 bipartisan sponsors and cosponsors, and is backed by over 60 Tribes and 1,500 organizations representing state fish and wildlife agencies, sportsmen and women, conservation groups, and industry associations and businesses.



Planning and Development Division

Project Management

- The project manager completed the resurfacing and restriping of the parking lot at the Desert Outdoor Center.
- The rebuilding of the Lake Pleasant 10 Lane boat ramp ET Bed started in mid-March and is expected to be completed by the end of May.
- The McDowell Campground electrical, plumbing, and campsite design was completed at the end of April. This
 project will upgrade campsite pedestals, hose bibs, switchgear, and add 14 new campsites in the south loop of
 the campground.

Trades Crew

- The Trades Crew completed the following:
 - Lake Pleasant
 - Repaired broken water line that provides water to the 10-lane restrooms. (The 2" waterline was leaking due to a failed coupler)
 - Troubleshot and installed a new water heater for the group Javalina campground.
 - · Repaired the dump station and Discovery Center septic clogs.
 - Repaired staff support air conditioning and performed preventive maintenance on electrical gears
 - Removed old blue building located at the 10-lane east parking lot
 - Addressed Bajada lift station, retrofitted photocells, and repaired lighting at various locations with LED lights, and completed preventative maintenance on chlorinator stations.

o McDowell

- Repaired the Pressure Reducing Valve on the main water line at the Four Peaks area.
- Replaced iron rangers.
- Spur Cross Removed and installed a new style Iron Ranger at the entrance.
- HQ Replaced exhaust fan and replaced six bad hand dryers throughout the park system.
- o Desert Outdoor Center
 - Troubleshot and repaired the walk-in cooler condensing unit.
 - Animals now have a new Reverse Osmosis water system
- Hassayampa Repaired the domestic water line leak near the nature center.
- o Estrella spread 180 tons of decomposed granite on the berm.
- Buckeye Hills repaired air conditioning and replaced exterior lighting with LED fixtures.
- o System-Wide repaired electrical pedestals at various locations.

Maricopa Trail, Sun Circle, and Trailhead Facilities:

The following trail segments are currently in progress – Spur Cross and White Tank segments 1, 6, 7, 18, 20, 22, 27, 33, 35 76, and 77.

- Agreement preparation/negotiations
 - City of Phoenix IGA for Segment 7 Sun Circle/Maricopa Trail approved by the Board of Supervisors on 3/28/2022.
 - o CAP License application for Segment 76 submitted 12/15/2020.
 - WAPA (Western Area Power Administration) license applications (four) for Segment 76 were verbally approved 7/20/21. Pending receipt of the license for submittal to Board of Supervisors.
 - o ADOT Guadalupe Bridge re-construction with the multi-use path in planning. The I-10 rebuild project began in November 2021.

Construction

- Laid out the new connector trail with pin flags at Usery in April 2022. Construction to be scheduled when final Cultural Resource Survey report complete.
- The OHV trail re-route due to construction at Vulture Mountain. Currently working with the Trades Crew to assemble rental equipment and schedule.
- Hiked new trail at Estrella Park connecting two sections of the Gadsen Trail with a consultant archeologist 4/21/2022. Construction to be scheduled when final Cultural Resource Survey report complete.
- Reviewed options for high school mountain bike competitions at Estrella Comp Track with bike club and management.
- Determined re-route around eroded Goldmine Trail at San Tan in April 2022. Ordering Cultural Resource Survey for construction.

- Maintenance
 - Continued AmeriCorps (ACE) crew deployment from January 2022 and will complete 5/18/2022. Currently working in Spur Cross and White Tank Parks. Funding provided by the American Recovery Plan Act (ARPA).
- Route Determination
 - Segment 77 Vulture Mountain to Lake Pleasant Submitted route to BLM 1/25/21. Site visits completed April 2021. Refined new trail routes in January 2022. Completed connection between Hassayampa River Preserve and Vulture Mountain April 2022.
 - Segment 76 White Tank to Vulture Mountain Submitted route to BLM 1/25/21. Site visits completed May 2021. Refined route December 2021. Holding monthly BLM (Bureau of Land Management) meetings. Working with BOR (Bureau of Reclamation) and CAP (Central Arizona Project) on CAP canal alignment near Hassayampa River.

Natural Resources


- The Natural Resource Specialist (NRS) contracted with the National Park Service (NPS) under the current IGA
 to treat Invasive species at Spur Cross Ranch Conservation Area. The NPS spent six days treating 40 acres of
 invasive species along the trails and riparian habitats.
- In addition, the NRS finished up the Desert Defenders program in April with a total of 115,598 plants removed within 30 acres at four parks.
- The NRS hosted three Native Seed Harvest events where volunteers helped collect native seeds within the parks. Thus far, we have a total of approximately 22 lbs. of seed, representing 14 species.
- The NRS has spent the last few years developing baseline data and current conditions for all the parks and prepared a draft of the Natural Resource Plan. The plan is currently going through staff edits and should be completed and ready to roll out with the 2030 Parks Vision Strategic System Master Plan.


Parks Planner

- Parks Vision 2030:
 - o Continued progress on Chapter 2: Existing Conditions, Chapter 5 Outreach, and GIS mapping data.
 - Met with staff from the County's Planning and Development Department to discuss the Parks Vision 2030 project and other development projects.
 - Maricopa County Parks and Recreation Department has been accepted to do a presentation on the Parks Vision 2030 plan at the 2022 National Recreation and Park Association conference in Phoenix, September 20-22nd this year. A session application request has also been submitted to the Arizona chapter of the American Planning Association (AZ APA) for their conference this August in Paradise Valley.
- Tribal Communities: Coordinated a meeting requested by the Salt River Pima-Maricopa Indian Community with
 the Maricopa Trail Manager and Natural Resource Specialist. The main topic of discussion was the Sun Circle
 and Maricopa Trail which use the Salt River Project Operation and Maintenance roads as the trail through this
 area. Suggestions were made for new trail signage to alert users where they are and to stay on the trail. Drafting
 text to add to the Parks' maps so users know where tribal land is located and that it is not permissible to access.
- The Parks Planner met with North Valley Outdoor Network (NVON), Lower Gila River Collaborative, and NVON
 Trail Connectivity groups. Discussion centered around bringing in cities and towns to review their park and
 pathways plans to help MCPRD start to collect important information for the regional trail system plan update.
- A consultant has been contracted for a trail cultural resources study needed in Estrella Mountain Regional Park.

Parks Operations Report

Interpretive Ranger Programs (FY22 through April)





Cave Creek Regional Park

- Completed two mine closures.
- On March 11-13, Ultraman Arizona (UMAZ) Day 1 swim event occurred at Lake Pleasant, Day 2 and Day 3 at Cave Creek Regional Park for the finish area. UMAZ is a three-day ultra-triathlon. Approximately 45 athletes rode bicycles 171 miles around the valley on day two and finished at our Ramada group area. The participants ran 52.4 miles on day three and finished at our Ramada group area.
- The Spur Cross and Cave Creek staff and some exceptional volunteers completed the last three mine closures this month. We are happy to say that this 2-year project is completed with 13 mine closures. The staff will monitor the sites annually to make sure everything is intact.
- The Spur Cross Interpretive Ranger and Cave Creek maintenance staff have been busy installing fencing to the east boundary.
- The maintenance crew has assisted the park host in cleaning up two illegal dumps at Adobe this month. We
 were able to identify one of the contractors that dumped one of the loads by an invoice that was found in the
 debris. We called MCSO for assistance and the contractor sent his crew out to pick up everything they had
 dumped.

Desert Outdoor Center

- The Rangers welcomed 1,236 students and 248 teachers/chaperones to enjoy over 68 outdoor education programs in March.
- For their third visit this school year, Notre Dame Catholic Prep brought 50 students to participate in their Kairos retreat.
- The facility was rented for one very special wedding event for Jamie Cardin and Devan Aare-Meza, which 100 wonderful guests attended.
- In April, 13 schools brought over 1,000 students and chaperones, with Archery and Survival being some of the more popular programs this month.

- Our facility also hosted two non-program groups, Notre Dame Preparatory High School and Bourgade Catholic High School, both of which hosted their retreats for 132 visitors.
- The Ranger Office has new vinyl flooring and rearranged furniture to make space for all the rangers to use the shared office more efficiently.
- April was a busy wedding month for the Center. We hosted four ceremonies/receptions, bringing about 500 guests that otherwise would have never had the opportunity to visit our facility.
- On the last Saturday of the month, we welcomed 116 Girl Scouts and 25 adult leaders on a Desert Survival Theme Day organized by a young lady working to earn her Gold Award Take Action Project, which is similar to the Boy Scout Eagle project and award.

Estrella Mountain Regional Park

- On March 5th, several car clubs gathered in some reserved ramadas and some first-come, first-served areas ramadas. Altogether, about 100 detailed cars and 300 spectator vehicles showed up. About 1,000 people were enjoying the park and the fine weather.
- The next step of auctioning the remaining rodeo arena items, such as panels, gates, and chutes was held in April.
- Turf area tree trimming and general clean-up occurred to prepare for the busy Easter weekend. In addition, the park staff performed general trail maintenance on some front country trails.
- Easter weekend was very busy this year at Estrella. All 25 picnic ramadas were rented and many locations in between ramadas were full of family gatherings. There were many positive comments from the public enjoying the renovations and new ramadas.
- Post-Easter weekend, the staff and hosts cleaned up leftover eggs, confetti, and general Easter gathering picnic remains.

Hassayampa River Preserve

- A Request for Proposal (RFP) process has been started for the Hassayampa Visitor Center's exhibits.
- Planning continued in March for several upcoming events, including the area BioBlitz (biodiversity citizen science project) and several wildlife research projects. The Preserve participated in the Hassayampa Ecosystem Bioblitz in which dozens of volunteers documented as many species of plants and animals as possible within 24 hours.
- The Preserve and Friends of Hassayampa hosted the annual Nature Poetry contest. A record number of entries were received. Winning poems will be displayed along the trails throughout April.
- Staff hosted an end-of-season volunteer lunch to thank hosts and community volunteers for their hard work this season.
- Staff attended Butterfly Monitoring training hosted by the Department's Natural Resource Specialist and participated in the subsequent butterfly count at the Preserve.
- Park maintenance staff repaired a significant water leak with the assistance of the Trades crew supervisor.
- Preserve staff and volunteers also participated in returning the in-person event, *All Vulture's Eve*, sponsored by the Town of Wickenburg to celebrate the spring migration of turkey vultures through the area. Approximately 210 people attended the event held at the pedestrian bridge in Wickenburg.

- April was a busy month at the Preserve. High visitation continued throughout the month.
- The Trades crew completed some septic system electrical repairs.
- At the beginning of the month, the park supervisor and several MCPRD rangers staffed discovery tables at the Mesquite Festival in Wickenburg.
- The Preserve partnered with Vulture City to be one of three venues hosting the *Impressions of Vulture Mine City Art Show*.
- Staff met with The Nature Conservancy for continued planning to transfer the remainder of the Preserve to MCPRD.
- Interpretive rangers and volunteers conducted seven on-site programs, including a Butterfly Monitoring and a Palms Discovery Station, highlighting the 150-year-old palm trees in honor of Arbor Day at the Preserve.

Lake Pleasant Regional Park

- Our winter volunteers are starting to depart we say goodbye to Chuck and Lisa, who helped us tremendously in our Entry Station booths. We also say goodbye to Jan who helps keeps the Discovery Center up and running.
- American Conservation Experience finished their trail work assignments at the Lake. They will still be in the park as they complete their Maricopa Trail assignments.
- Air Quality Control fuel tank inspections we passed. But unfortunately, the Discovery Center restrooms are up and down again this month.
- Hosted three volunteer clean-up events for a total of about 150 people. Also, hosted the Ultraman Triathlon Race event - all went well.
- Hosted a CAP Legislative Affairs tour showcasing the Dam and CAP's involvement.
- Bald Eagle closure has been administratively lifted as of the end of March and staff removed the physical closure on April 6th.
- A sure increase in visitation occurred during various Spring Break sessions, and we are moving into our spring/summer seasons.
- The Discovery Center will remain closed until further notice due to a lack of personnel.
- The Roadrunner Campground improvement project has been delayed from July 2022 to July 2023 due to a 50-week delay in parts.
- The Dam Good Run went off without a hitch on Sunday, April 3rd.
- Easter Weekend (April 17th) was busy but manageable.
- Scorpion Bay Marina is moving along with its rental cabins.

McDowell Mountain Regional Park

- The snakes are out, with the wintering snakes coming from underneath the Visitor Center. Park visitors enjoyed seeing them from a distance.
- The park hosted the annual Host Appreciation Celebration with deli sandwiches made to their order.
- Several fence cuts along the eastern boundary with Fort McDowell Indian Reservation allowed the cattle to come into Escondido Tank for water.
- The trailer porta-potty toilets at Minks Camp went out of service due to a possible tank leak.
- The Visitor Center was painted, leak prevention implemented, and the area cleaned up around the building to improve its appearance.
- Plumbing repairs were completed at the entry station due to leech field problems.
- Completed trail maintenance on Pemberton Trail to repair erosion from wash areas.
- Cactus Cup was held in mid-March with 735 bikers riding through the desert
- Hike for the Homeless had 298 hikers raising funds for the homeless.
- REI held a large event in the youth campground, drawing in a few hundred people.
- New iron rangers were installed at the 150th and the 158th entrances. Additionally, the 168th entrance will get a new Iron ranger soon.
- The park entrance gate was backed into by a trailer which caused it to hang up periodically. Trades crew came out and repaired the gate.
- Septic lines were flushed at host sites, and locations have been identified that need to be pumped.
- Small projects for future months are being identified and scheduled with maintenance.

San Tan Mountain Regional Park

- San Tan sold 638 annual passes in March and 421 in April.
- The Ranger Nikki presented two programs at Usery (Natural Resources butterfly program and wildflower walk) and two programs at Estrella (wildflower walk and a well-attended homeschool discovery station).

- Ranger Nikki also assisted with one field trip at the Desert Outdoor Center and led a Desert Defenders invasive species pull at White Tank.
- Park Staff Rick and Blake facilitated the Volunteer Appreciation party at Usery park.
- The San Tan Shredders bike group held a bike rodeo skills clinic for 15 children.
- The 364-house development project outside the main gate started and the construction company donated seven Barrel cacti. Park Maintenance planted them around the Nature Center complex.
- Park volunteer Peter led the San Tan Trail Runners group in a trail work project to make repairs on Dynamite Trail.
- Aravaipa held its annual Night Bike Race (92 participants) and Night Running Race (345 participants).

Spur Cross Ranch Conservation Area

- The Interpretive Ranger and Spur Cross Trails Volunteers assisted the maintenance staff at Cave Creek with the installation of a memorial bench and completed two mine closures.
- On March 25th, the Sierra Club assisted in weed removal around the parking area. On March 19th, the park held a Desert Defenders Program, including weed removal around the parking lot and Dragonfly Trail. Finally, on March 26th, a Butterfly Monitoring program was held with seven attendees.
- Staff completed minor trail work.

Usery Mountain Regional Park

- Usery Park and San Tan staff hosted the end-of-year Host celebration party for Usery and San Tan hosts; all that attended had a wonderful time, and many were happy to see the celebration(s) reinstated this season.
- Several Park Hosts left early in March, remaining hosts and staff did an awesome job at handling all as March is typically our busiest month.
- Park Hosts at the Archery Range has been rebuilding and repairing several target butts throughout the range before they head out for the season.
- The maintenance staff has been busy weeding and trimming around our Nature Center, Entry Station, and Restroom areas.
- Ranger Nikki and Ranger Dave have been performing public programs at Usery Park, and many have enjoyed them
- Our campground has remained full throughout April; we've relied on our Overflow area for additional camping throughout several weekends.
- Cub Scout Pack 380 participated in a clean-up project, completing trash pick-up and trail work around Merkle Trail, the Nature Center, and the front of the park entrance.
- The maintenance staff has continued work with weeding and trimming around our Nature Center (amphitheater) and several parking lots and restroom areas.

White Tank Mountain Regional Park

- A hazard was identified at area 1 restroom, a four-inch drop where the pavement met the trailhead; we filled the area to grade with fill dirt and finished with ¼- decomposed granite.
- The wash before the competitive track had significant potholes; staff filled and compacted with the tractor.
- Boulders were strategically placed at the comp track, where visitors wandered off-trail.
- The White Tank Mountain Conservancy held its Steward Appreciation Event on March 5.
- McDowell Mountain Cycles held their adopt-a-trail event on Saturday, March 5th. Mesquite Canyon Trail Runs on March 5th was part of the Desert Runner Trail Series.
- On March 30th, the Area 4 closure for construction coordination meeting was held.
- On March 31st, staff held our Volunteer Appreciation lunch with all hosts and Senior supervisors present.
- Staff is excited to announce we have 11 summer hosts working this year!
- Partitions in the family camp men's restroom were damaged and were repaired using metal plates and bolts.
- · Continuous roadside vegetation removal.
- Boulders were placed in the family campground to prevent unauthorized parking in the desert vegetation.
- On April 9th, White Tank Park hosted the 2022 Hassayampa Ecosystems BioBlitz with the Arizona Game and Fish Department, the Arizona Chapter of Wildlife, Maricopa County Parks, and several other partner organizations that mapped out the biodiversity of our desert ecosystem with 58 observers.
- On April 13th, the parks held the Black Rock Adopt-A-Trail clean-up event.
- A Bird Walk with Ranger Eric had 10 participants.
- On April 16th, a Native American Style Flute concert was held at the Nature Center with 26 participants.
- The Saguaro 7k run was held on April 16th with 38 participants.












NUMBER OF INDIVIDUALS WHO COMPLETED THE CHALLENGE
