Re:	Director's Summary of Current Events

Listed below are activities the department has been involved with during August 2020.

Estrella – Tres Rios Golf Course:

On July 6, 2020, the Concessionaire gave notice to the County of its intent to terminate their agreement early. On August 14, 2020, the Concessionaire notified the County that it plans to close Tres Rios Golf Course on August 17. On August 14, 2020, the Concessionaire sent terms for termination; monthly minimum paid through December 31, 2020, (a total of \$33,870.99) and one salaried employee in place until October 17 for irrigation maintenance and mowing the t-boxes, fairways and greens. On September 2, the concessionaire removed the one-salaried person from the facility, leaving the course with no mowing/irrigation maintenance staff. On September 2, the County issued a default letter. On September 4, the Concessionaire again offered to pay the original funds of \$33,870.99 to settle the default and terminate the agreement. This offer will be presented to the Board of Supervisors on September 16, 2020, for consideration.

County Manager, Joy Rich, has approved an emergency procurement for irrigation maintenance and mowing until a new Concessionaire has been placed. Staff is currenting reviewing proposals for immediate mobilization as the last mow was on September 1, 2020.

Concurrently, a Request for Proposal for a Use Management Agreement for the Tres Rios Golf Course was issued on August 24 through our website and August 25 through the County's BIDSYNC, with a response due date of August 31. The County received five responses and the selection committee has narrowed down to three responses for due diligence and negotiations.

Planning and Development Division

Project Management

- The Department Project Manager (PM) met with the Job Order Contractor (JOC) on the Lake Pleasant entry gates projects. The project will install solar powered entry gates at the entry of the main park entrance road and the north entrance at Castle Hot Springs Road to better secure the park.
- The Group Campground host site project is moving along at Lake Pleasant. The host site covers have been ordered, the electrical infrastructure is in permitting, and the septic system and potable water connections have been designed. This project will be completed by the end of the calendar year.
- The PM is obtaining bids for several park projects including septic tank replacements at Usery Mountain Park and RV dump stations repairs at Cave Creek Regional Park.
- The PM met with the Department's new electrical JOC contractor to review the Roadrunner Campground electrical project at Lake Pleasant Regional Park. After consultation with the contractor, the project can be divided into several phases to reduce overall impact to park visitors and revenue.

Trades Crew

- Department Electricians completed the installation of retrofit LED lighting on the host sites at McDowell Mountain Regional Park.
- The Trades Crew began installation of several folding tables at the Department headquarters building at Lake Pleasant Regional Park. The space saving tables maximize the room's space and allows for better use the limited space.
- The Trades Crew and department electricians have completed utility installation on the new host site at the campground at McDowell Mountain Regional Park. This site was installed at the end of last fiscal year but required utilities to be functional. This site allows additional site-based volunteers to help with operations at the park.

Trails Crew

• The Trails Crew is completing final touches on the new trail addition to the competitive track at Estrella Mountain Regional Park. This addition is approximately 2.0 miles and provides an additional route and challenges for the riders on the track.

Maricopa Trail, Sun Circle, and Trail Facilities:

- Agreement preparation/negotiations:
 - City of Phoenix IGA for Segment 1 under review by the Phoenix Street Transportation Department (sent on 2/27/20).
 - ADOT Preparing permit for SR85 crossing Segment 33.
 - Daisy Mountain met with State Land on 6/18/20. They propose a Special Land Use Permit instead of an easement.
 - AZGFD Segment 14 license renewal was approved by their Commission on 8/19/20; will be placed on future Board of Supervisors' agenda for County approval. Segment 33, waiting for draft license.
- Trailheads
 - o Segment 11 Preparing display for new kiosk at Sun Valley Trailhead.
- Sign Installation, Inventory, and Mapping

- o Completed signs and inventory/mapping: Segment 27 August 2020.
- Route Determination Developed alternate routes for Segment 77 Vulture Mountain to Lake Pleasant and Segment 76 White Tank to Vulture Mountain. Parks management selected primary routes in August 2020. Currently meeting with landowners (Bureau of Land Management, Central AZ Project, Bureaus of Reclamation, and Western Area Power Administration.

Natural Resources

- The Natural Resource Specialist has been working with volunteers to scatter recently gathered native species seed back onto the burn scars at both Cave Creek and White Tank Mountain Regional Parks. Unfortunately, the Natural Resource Specialist and volunteers will need to complete an additional post fire assessment in the area of the recent fire at McDowell Mountain Regional Park which burned over 600 acres.
- The Natural Resource Specialist has been working with plant experts from the Midwest and local partners on creating a Floristic Quality Assessment tool for the local Maricopa County area. Floristic Quality Assessments (FQA) are a tool used to assess an area's ecological integrity based on its plant species composition. Once the tool has been tuned to the local area and applied, an index can be created to determine the overall conservation value of the landscape or area being studied.
